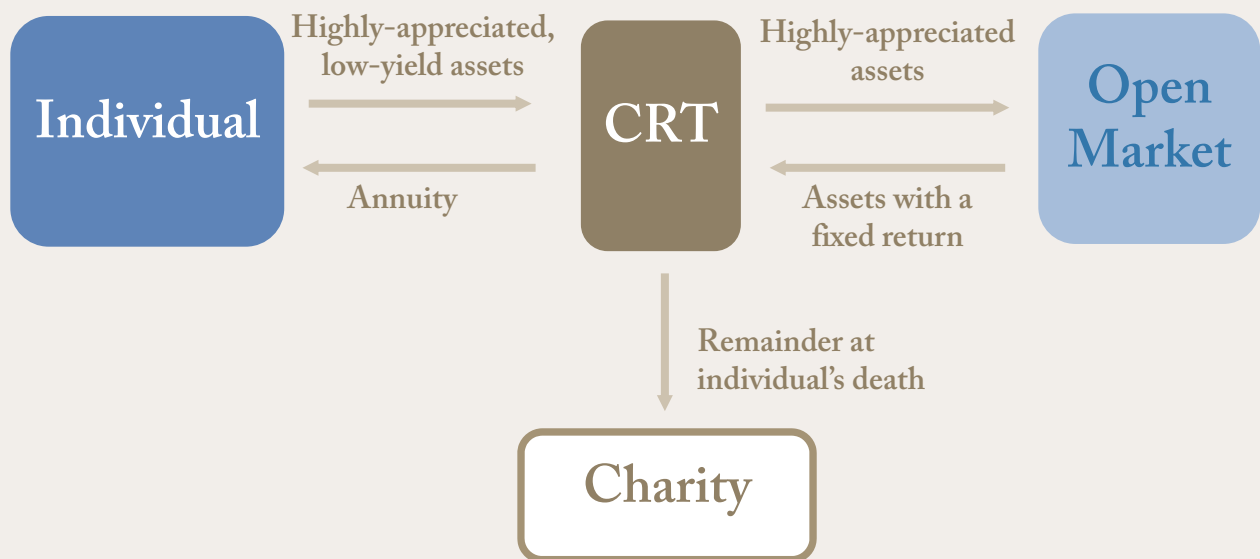


Charitable Remainder Trusts
